Who we are

The Greater Manchester Combined Authority (GMCA) is made up of the ten Greater Manchester councils, the Greater Manchester Fire and Rescue Service, and the Mayor of Greater Manchester. We work with other local services, businesses, communities and other partners to improve the city-region.

Summary of the survey

This survey is about the green food and garden bin/food caddy in Oldham. We would like to gain an understanding of residents' behaviours and motivations around recycling and reducing food waste.

What information we will collect from you (the purpose and legal basis for processing information)

Recycle for Greater Manchester are currently running a campaign called 'Buy Keep Eat Repeat' in Oldham to help residents reduce and recycle any food waste. This survey is aimed at residents who live in Oldham and have a green food and garden bin/food caddy. The survey will ask you some questions about why you may or may not use the green bin for recycling food waste, and how you dispose of food waste if you don't recycle it. There are also questions focused on food waste, such as why food is sometimes thrown away in households, what you do to help reduce the amount of food you throw away, and what support is needed to help reduce the amount of food that is thrown away. We would also like to find out what would motivate you to recycle any food waste in your caddy/green bin. Finally, there will be some questions on the current Buy Keep Eat Repeat logo and other existing food waste campaigns. The responses to this survey will help to shape the future messaging of the Buy Keep Eat Repeat campaign.

We will collect the following information in order to ensure we hear from a representative selection of Greater Manchester communities, and to ensure any policy decisions or interventions are based on the needs of different communities:

- The local authority area you live in
- Your green bin collection day

- Your age bracket
- Your ethnicity
- Your religion
- Your gender identity
- Whether you identify as trans/transgender
- Your sexuality
- Whether you have a disability

We are asking for this as we want to make sure we hear from Greater Manchester's diverse communities, and also to ensure any policy decisions or interventions are based on the needs of different communities.

- As the GMCA has legal responsibilities for the wellbeing of Greater Manchester residents, the legal basis for undertaking this survey and using the survey data will be:
- Article 6 1(e) processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller
- And for the more sensitive data:
- Article 9 2(g) processing is necessary for reasons of substantial public interest

How we ensure the security of your data

The GMCA is committed to the security of the information we collect and we use reasonable measures to prevent unauthorised access to that information. We are required to demonstrate that our solutions meet the required levels of personal, procedural, policy, data and technical security. We will only process personal information for the purposes it has been collected or subsequently authorised.

This survey is hosted on software called Citizen Space, which is provided by Delib. The security measures, firewall, access control and administration privileges for the Delib service have been reviewed and accepted by the GMCA. We also have a contract in place with Delib, which states the services they must provide.

The data from this survey will not be transferred to any other third party for processing.
Information retention

The GMCA will keep your information for three years from the point at which the survey closes. We may keep your information in an anonymised format after this time for statistical purposes and in these cases, all personal information will be removed.

Transferring data

All data collected as part of this survey will remain in UK.

Data sharing

The information collected as part of this survey will only be used by the GMCA for the purposes explained above.

What rights do individuals have?

The GMCA must comply with the General Data Protection Regulations (GDPR) and the Data Protection Act 2018.

Under data protection law, your rights include:

- Your right of access - You have the right to ask us for copies of your personal information.
- Your right to rectification - You have the right to ask us to rectify information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
- Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.
- Your right to restriction of processing - You have the right to ask us to restrict the processing of your information in certain circumstances.
- Your right to object to processing - You have the right to object to the processing of your personal data in certain circumstances.
- Your right to data portability - You have the right to ask that we transfer the information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
